

Installation Guide



These instructions are not intended as a service or overhaul manual. These instructions are intended to facilitate the modification of non-factory parts installation by a trained professional.



CONTENTS:

- A (36) Head Studs
- B (12) Head Bolts
- C (36) Flat Washers
- D (36) 12 Point Flange Nuts
- *E* (1) Fastener Assembly Lubricant 1-oz

Inspect for damage or defects and clean all hardware prior to installation. Verify product part number matches your application.

Clean all threads in the engine block. Use a Bottoming Thread Chaser if necessary to ensure thread engagement, and more accurate torque readings.

NOTE:

Loctite may be used for permanent mounting. Torque sequences must be complete prior to Loctite hardening.

Install Head Studs (A) into the block. Hand-tighten without tools (equivalent of 20-30 in. lbs.).


Install cylinder heads and check for proper alignment.

Lubricate Head Stud (A) threads, Flange Nuts (D) and Flat Washers (C) with the Fastener Assembly Lubricant (E) provided. Install the Flat Washers (C) and Flange Nuts (D) on to the Head Studs (A).

Tighten Flange Nuts (C) in three equal steps (50/100/150) using the torque sequence (**Fig 1**) to a total spec of 150 ft lbs.

Lubricate Head Bolts (B) with Fastener Assembly Lubricant (E). Install and tighten Head Bolts (B) to 25 ft lbs.
