

Performance products can increase horsepower above and beyond factory specifications. Additional horsepower creates more stress on the drive-train components, which could result in drive-train failure.



- 1 (A) Front Differential Cover
- 12 (B) Washers
- 12 (C) M8 x 1.25 x 35mm Allen head bolts
- 1 (**D**) Fill Plug (installed)
- 1 (E) NPT temperature probe access plug (installed)

BEFORE BEGINNING:

Engine is off, vehicle is cool.



STEP 1

Drain and recycle used oil. Remove stock cover.

Clean factory gasket for reuse.



STEP 2Thoroughly clean differential mating surface.



STEP 3

Remove, inspect and clean factory gasket.




STEP 4Align factory gasket to PPE Front Diff Cover.



STEP 5

Install Cover and gasket using washer and bolt hardware, finger tight.





STEP 6

Tighten bolts using a crossing pattern shown above. Torque bolts to 18-20 ft. lbs.



STEP 7

Remove Fill Plug. Fill to sight-level with high-quality gear oil. Replace Fill Plug and tighten.

Installation complete.
