



### Step 1

Remove stock oil fill.



### Step 2

Bolt centrifuge base to PPE oil filler tube.



### Step 3

Install rubber gasket to base.



### Step 4

Lube the oil filler tube.



### Step 5

Install oil filler tube using stock bolt.



### Step 6

Install 45 degree fitting to base of unit.



**Step 7**

Remove resonator.



**Step 8**

Remove NPT plug from the oil filter assembly. Install fitting for feed line.

Remove this plug.




**Step 9**

After installing feed line, route the feed line across the engine to fittings.




**Step 10**

Use Zip Ties to secure oil line.



**Step 11**

Install Centrifuge "Bell" onto spindle. Install nut to secure.



## Step 12

Install fan shroud support bracket.
