




#### **PROCEDURE**

- 1. Remove contents from box, verify if all parts listed are present and free from damage. Carefully read and understand all instructions before attempting installation.
- Failure to identify damage before installation could lead to a rejection of any claim.
- 2. Locate the mount locations on the rocker panel of the vehicle. Remove the rubber plugs covering the threaded holes.
- 3. Locate (1) Mounting Bracket (Item 4) and loosely secure it to the rocker panel using the provided hardware: (2) M8 hex head bolt (2) M8 flat washer, and (2) M8 lock washer. See **Figure 1.** (**Note:** If threaded holes are not on trucks rocker panel, remove the rubber plugs located on the rocker panel at each mounting location and insert nut clips.) See **Figure 3**.
- 4. Repeat Step 4 for every other bracket mounting location, see Page 3 for bracket orientation and location.







5. Locate (1) Center Mount Bracket (Item 2-3). Loosely secure Center Mount Bracket to the rocker panel using (2) M8 hex head bolt (2) M8 flat washer, and (2) M8 lock washer. See **Figure 2.** Refer to **Page 3** bracket orientation figures.



- 6. For Step Board installation, mount the board to previously installed brackets with the supplied M8 hardware. See Figure 4
- 7. Align and adjust the step bars and brackets as needed, then fully tighten all hardware: M8 to 15-18 ft-lbs.

- REGULAR WAXING IS RECOMMENDED. DO NOT USE ANY TYPE OF POLISH OR WAX THAT MAY CONTAIN ABRASIVES.
