



Assembly Instructions:

Before Use, remove 4 mounting screws and reinstall with Red Loctite. Torque to 18-22 ft lbs.

Assembly is shipped un-torqued.

Install either an oil pressure gauge or the 1/8" NPT Pipe Plug,
