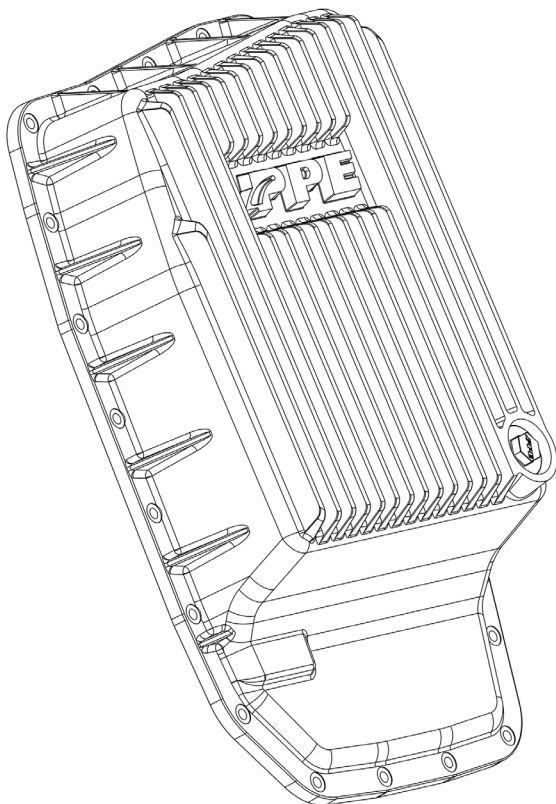


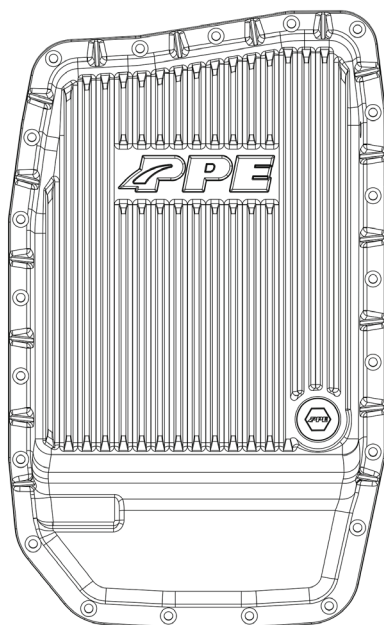


Heavy-Duty Cast Aluminum Deep Transmission Pan - Ford 6R80/6R100

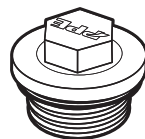

- A** (1) 6R80 Deep Transmission Pan
- B** (1) Neodymium Magnetic Plug (installed)
- C** (1) 1/8-inch NPT plug (installed)
- D** (21) M6-1.0 x 25mm Socket Head Cap Screws
- E** (21) M6 Flat Washer



INSTALLATION:

- Step 1.** Vehicle off. Engine cool.
Completely drain oil. Overnight, if possible.
- Step 2.** Remove stock pan bolts. Save and clean reusable gasket.
- Step 3.** Clean any debris from factory filter
- Step 4.** Fit reusable gasket on to new PPE pan.
- Step 5.** Align the four filter support posts in the PPE pan with the bulges under the factory filter. Push pan up into place. Install two bolts to hold pan in place. Finger tight for now.
- Step 6.** Install remaining bolts. Tighten in crossing pattern as depicted.
Torque bolts to 8-10 ft. lbs.
- Step 7.** Tighten NPT snug.
Tighten drain plug 18-22 ft lbs.
(Be mindful not to crush the O-ring)

- Step 8.** Fill with manufacturer recommended transmission fluid.

Check for leaks.

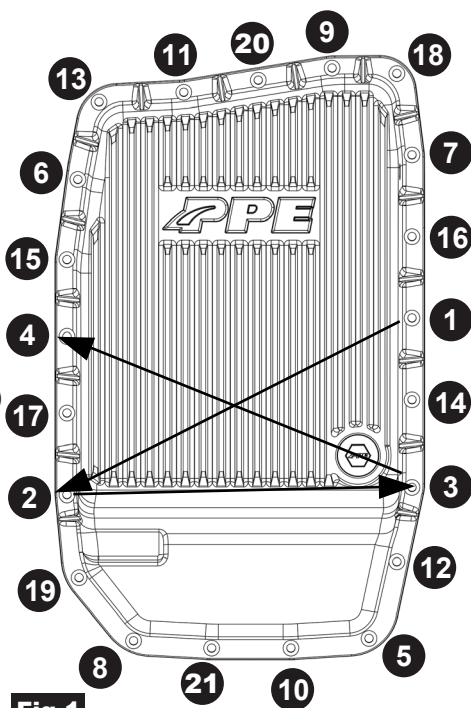
